Policy and lawmakers, regulators and organizations continue to grapple with what it means for organizations to be "accountable" as required by an increasing number of privacy laws and regulatory guidance. At the same time, an increasing number of these stakeholders are beginning to link organizational accountability to having comprehensive internal privacy programs comprising policies, processes, tools and measures to govern all aspects of data processing.

This webinar will explore how organizations today are implementing such accountability programs and how the CIPL Accountability Wheel provides a useful framework for such programs. Key insights and practical examples from CIPL's recent Accountability Framework Mapping Report will be discussed. In addition, the webinar will look at the positive returns that organizations are experiencing from investing in such privacy accountability programs and will explore key findings from CISCO's recent Privacy Benchmarks Study. It will also touch on other relevant developments in the area of accountability, such as the U.K. ICO's Accountability Toolkit and the FTC's privacy consent orders requiring comprehensive privacy programs.
