- Privacy and Data Protection Regulators will share their perspectives on the value of organisations' ability to use their internal accountability frameworks to demonstrate compliance with applicable laws. Specifically, they will consider (1) how such accountability documentation can be used as evidence of compliance, (2) whether there are benefits for organisations to go above and beyond legal compliance in devising their internal privacy

management programs, and (3) whether there is promise in using accountability-based cross-border systems to bridge different jurisdictional compliance requirements.
