CIPL and CEDIS-IDP invite you to the fifth webinar organized as part of our <u>joint-project</u> on the "Effective Implementation and Regulation under the New Brazilian Data Protection Law (LGPD)".

The LGPD requires controllers to appoint a person to be in charge of the organization's data processing activities (Article 41), which, in practice, means their data privacy compliance and data privacy management program. This person, called the "encarregado" or, most commonly, the Data Protection Officer (DPO)—will (i) serve as the main point of contact between the controller, data subjects and the ANPD (Article 5, VIII); be responsible for acting upon data subject and ANPD requests (Article 41, paragraph 2); and provide advice and guidance to the organization on data protection and LGPD compliance (Article 42, paragraph 2).

This webinar will focus on the basic aspects of the LGPD and key challenges concerning the role of the DPO, the difference between the requirements of the LGPD and of other jurisctions such as the GDPR concerning this role, and practical examples of how international organizations have structured this role internally.

This webinar will be followed by a smaller roundtable in Portuguese, to discuss the more specific challenges that Brazilian organizations are facing in relation to appointing a DPO and the specific points that are still open for the Brazilian data protection authority (the Autoridade Nacional de Proteção de Dados—ANPD) to regulate and provide guidance on.

- Can organizations leverage internal resources to perform the role of the DPO such as DPOs appointed in other jurisdictions, or people working on other roles?
 Can they contract an external DPO?
- Does the DPO have personal liability for data protection non-compliance under the LGPD and other Brazilian laws?
- What is the difference between the role of the DPO under the LGPD and the European General Data Protection Regulation (GDPR)?
- Does the Belgian DPA decision on the Proximus case have any impact on how organizations subject to the LGPD should appoint their DPO? Could this decision have any impacts on the ANPD's future guidance on this topic?
