This session will center on examples and practical demonstrations of how controllers and intermediaries/processors of all sizes are delivering accountability, focusing on the role of the DPO, documenting data processing and demonstrating accountability. Specific questions to be addressed include:

- Why is it in an organisation's self-interest to build a systematic data protection management programme? What are the benefits of accountability for large organisations and SMEs and for controllers and intermediaries/processors?
- How to start a data protection management and compliance programme understanding the data, senior management support, governance?
- What is the role of the DPO in organisational accountability?
- What are documentation best practices in relation to data processing?
- How can organisations, including SMEs, demonstrate accountability internally and externally (internal personal data protection programmes, data protection certifications, codes of conduct and BCR, APEC CBPR and PRP)
- How does accountability enable cross-border data flows?

11:00 Session II: Transparency, Legal Bases for Processing (Consent, Notification of Purpose and Legitimate Interest) & Data Protection Impact Assessments (DPIAs)

This session will discuss practical implementation issues relating to transparency and notification requirements, as well as to different bases for processing, in particular consent, notification of purpose (or "deemed consent by notification") and legitimate interest. Specific questions to be addressed will include:

- What is transparency and how can information be provided to individuals in different contexts in clear, understandable, concise and innovative ways?
- How can notification of purpose and opt-out mechanisms be provided effectively?
- How to implement disclosure requirements relating to legitimate interest, (i.e. disclosure of reliance and justification of reliance)?
- How to determine which legal bases for processing should or can be used?
- How will the "accountability measures" (risk and impact assessments and mitigations) for notification of purpose and legitimate interest work in practice?
- How to balance and weigh the benefits of processing against foreseeable adverse impacts to the individual?
- What are the steps in a risk and impact assessment or DPIA?
