14:10 **APEC Member Economies Update on CBPR Implementation and Next Steps in Growing the CBPR System**

APEC regulators/governments will provide brief updates on how they are using or implementing the CBPR in their economies. They will address what motivates them to use CBPR, what promises they see in them, such as, for example, providing a mechanism for cross-border data transfers in the region, creating a privacy management and accountability tool for domestic compliance purposes, and supporting SMEs. In addition they may discuss the challenges they may be facing in implementing the CBPR and how they plan to overcome them. This will be followed by an open discussion between the regulators and industry participants, focusing on the respective roles of governments, regulators and industry in facilitating the uptake and growth of the CBPR in the region.
