#### 10:15 AM Topic II – Accountable Machine Learning and AI

This session will consider the privacy concerns raised by machine learning and artificial intelligence, as outlined in a discussion document. Do AI and machine learning raise new risks to individuals? If so, what are they? How do questions of human intervention in AI and machine learning processing affect the ability of companies to provide transparency and accountability? How do AI and machine learning challenge companies' ability to explain algorithms to regulators? What do these realities mean for governance? Panelists will also consider the extent to which existing data protection paradigms, such as accountability, can address concerns specific to AI and machine learning, and where additional guidance may be necessary to translate existing privacy principles into actionable requirements.
