# SPEAKERS BIOGRAPHY



Secretary for Information Technology Policy, Ministry of Science, Technology and Innovation

Virgilio Almeida is the Secretary for Information Technology Policy of the Ministry of Science, Technology and Innovation of Brazil. He is also a professor of the Computer Science Department at the Federal University of Minas Gerais (UFMG), Brazil. His areas of research interest include large scale distributed systems, Internet, social computing, autonomic computing and performance modeling and analysis. He received a PhD in Computer Science from Vanderbilt University, an MS in Computer Science, from the Pontifical Catholic University in Rio de Janeiro and a BSEE from UFMG, Brazil. He was a visiting professor at Boston University (1996), Technical University of Catalonia (UPC) in Barcelona (2003), Polytechnic Institute of NYU (2007) and held visiting appointments at Santa Fe Institute (2008), Hewlett-Packard Research Laboratory (2001) and 2004) and Xerox Research Center (PARC 1997).

Virgilio has published over 120 technical papers and co-authored five books on performance modeling, including "Performance By Design" (2004) "Capacity Planning for Web Services" (2002), and "Scaling for E-business" (2000) published by Prentice Hall. He has received, among others, the National Award in Informatics (1991) and the Great Cross of the National Order of the Scientific Merit in 2009. He is a full member of the Brazilian Academy of Sciences and TWAS, the Academy of Sciences for the Developing World.



#### Sérgio Alves Jr.

**Secretário Executivo**, Centro de Direito, Internet e Sociedade do Instituto Brasiliense de Direito Público (CEDIS/IDP)

Sérgio Alves Jr. is a researcher and the Executive Secretary of the Centre for Law, Internet & Society at Brasilia Institute for Public Law (CEDIS/IDP). He is also a legal advisor at the Executive Office of the President of Brazil (Casa Civil).

Sergio has researched and worked on Internet-related topics with the Berkman Centre for Internet & Society at Harvard University; Samuelson Law, Technology & Public Policy Clinic at the University of California, Berkeley; Kiva Microfunds (Kiva.org); DiploFoundation; International Telecommunication Union (ITU); National Telecommunication Agency (Anatel). He has represented Brazil at several ITU, Citel, Mercosur, and bilateral meetings and conferences, mostly to negotiate international telecom regulations, cybersecurity and Internet governance issues on behalf of the telecom regulator Anatel. #### José Alejandro Bermúdez



*Managing Director*, Latin America, Nymity & Former Colombian Superintendent for Data Protection

As Managing Director of Nymity's Latin American business, José Alejandro Bermúdez is a pioneer in establishing data protection regimes and an esteemed legal expert in data protection for Latin America. José Alejandro was the inaugural Deputy Superintendent for the Protection of Personal Data in Colombia, and he charted the path for Latin American data protection as the promoter of the Colombian Accountability Guidelines published by the Superintendency of Industry and Commerce (SIC). As a member of the Governmental commission appointed to draft the Colombian Data Protection Law (Law 1581 of 2012) and its secondary regulations, José Alejandro helped shape the data protection regulatory landscape in Latin America. A renowned international thought leader and speaker, José Alejandro was ad-hoc observer to APEC's Privacy Subgroup and the OECD Working Party on Information Security and Privacy in the Digital Economy, a member of the Colombian OECD Accession Mission (privacy and digital economy), and served as a member of the Executive Committee of the Ibero-American Network of Data Protection (RIPD). Before his term as Deputy Superintendent, José Alejandro served as Advisor to the Superintendent of Industry and Commerce and Coordinator of the Financial Data Protection Group of the entity. Prior to his term in government, José Alejandro was a partner at a leading Colombian law firm.

From 1972 through 1986 Dr. Getschko held a variety of positions within the University of Sao Paulo, from student to faculty and IT Professional. He was the manager of the São Paulo Research Foundation (FAPESP) Data Center, a state foundation that played a central role in the Brazilian academic networking, from 1986 through 1996. In 1996, Dr. Getschko left FAPESP to become technology director at Agencia Estado, an arm of a major Brazilian newspaper, where he was involved in strategic planning, focusing on the technological evolution affecting the information industry. Between 2000 and 2001 he joined iG (Internet Group), a free Internet provider in Brazil, as Chief Technology Officer and Vice-President of Technology.

Since 1995, Dr. Getschko has served as an individual member of Internet Society (ISOC) and he is currently the Vice-President of the ISOC Brazilian Chapter. Dr. Getschko served on the ICANN Board from 2005-2009. ## Gilmar Ferreira Mendes

Justice, Supremo Tribunal Federal (STF)

Gilmar Mendes is a Brazilian Justice of the Supremo Tribunal Federal (Brazilian Supreme Federal Court), since being appointed by then President Fernando Henrique Cardoso in 2002. Mendes was also the Chief Justice for the 2008-2010 term and the Solicitor-General from 2000 to 2002.

Gilmar Mendes was assigned to the Supreme Court by presidente Fernando Henrique Cardoso. During his tenure, Mendes took the position of vice-Chief Justice (2006-2008) and then took oath as Chief Justice (2008-2010). Mendes was also president of the Nacional Justice Council (2008-2010), and implemented a national plan to modernize Brazilian Justice, which resulted in the judgement of 2.72 million old cases (dated before 2006).[3] During his tenure, other measures were taken to enhance dynamism and efficiency in the Brazilian judicial system, such as the criation of the Electronic judicial process and the lower criminal and civil virtual courts, among others.

In addition to his role as a leading judge, Mendes has contributed to doctrine and research, having published many books, articles and participated in academic events.
